Coronavirus (COVID-19) Declaration, Waiver & Liability Release.

DECLARATION

I hereby declare to the best of my knowledge that within fourteen (14) days immediately preceding the date of this Declaration, Waiver & Liability Release that I:

- Have not tested positive or preemptively positive with the Coronavirus or been identified as a potential carrier of the COVID-19 virus;
- Have not experienced any symptoms commonly associated with the Coronavirus i.e.: fever ($\geq 38^{\circ}\text{C}$), cough, sore throat etc;
- Have not been in direct contact with or the immediate vicinity of any person I knew and/or now know to be carrying the Coronavirus or has been identified as a potential carrier of the Coronavirus?

I further declare that from the official start of the tour, until the official end of the tour, that I will:

- Follow all safety instructions issued by the Tour Leader;
- Wear a mask at all times, as instructed by the Tour Leader;
- Social distance from other guests, the tour leader, local leader and any support staff where reasonably possible;
- Take all reasonable hygienic and prophylactic steps to avoid the transmission of COVID-19 (avoiding physical contact, regular hand washing, use of sanitizer etc)
- Consent to having your temperature taken by any representative of the company, our sub-contractors, local service providers, local agencies or local government officials during the tour on request.
- Consent to depart the tour immediately should I begin to display symptoms reasonably consistent with COVID-19. On tours where a Rockjumper Tour Leader/s is present, they will follow a designated protocol covering symptom diagnosis and action, in conjunction with our insurers and crisis co-ordinators, SATIB24.

I, an individual over the age of 12 of sound mind, knowingly, voluntarily, and freely agree to the terms of this binding Declaration, and in doing so represent the truthfulness and veracity of the above answers.

WAIVER

Rockjumper Birding Limited and our local representatives and agents cannot prevent you, or your spouse, children, or other guests from becoming exposed to, contracting, or spreading COVID-19 whilst on a Rockjumper Tour. Any in-person interaction with, at, or during a Rockjumper Tour may increase your risk of contracting or spreading COVID-19.

WAIVER OF LIABILITY

I hereby forever release and waive all claims and rights against Rockjumper Limited, and their respective members, officers, directors, employees, contractors, agents, and representatives (the "Releasees") in connection with exposure, infection, and/or spread of COVID-19 related to utilizing Rockjumper's services. I understand that this release and waiver means I give up my right to bring any claims including for personal injuries, death, disease, property losses, or any other loss that may be released and waived under applicable law, including, but not limited to, claims of negligence on the part of the Releasees, and I understand that this release and waiver prevents me from seeking damages in any way against the Releasees, whether such damages are known or unknown, foreseen or unforeseen, or that occur now or in the future. I specifically give up my right to initiate suit against Rockjumper Limited for any matter contemplated by this release. I also intend this release to apply, to extent permitted under applicable law, to any claims my spouse, children, or guests could assert related to the subject matter of this release.

COVID-19 Safety Protocol

With the COVID-19 new normal in mind, our tours will operate in confidence under strict regulations for the foreseeable future. We are in this together, requiring that ALL guides and guests adhere to the following measures:

- Please do not greet anyone by hand and avoid physical contact at all times.
- Avoid touching your nose, eyes and mouth.
- Masks are to be worn for the duration of your tour. For example, on vehicles, airports, planes and in any social situations where social distancing is difficult. Your guide will authorize when not wearing a mask is acceptable such as in open situations when social distancing can be implemented. Guests are asked to please arrive with their own masks (N95, R95, KN95 or surgical masks) and that they must be worn according to [WHO safety standards](#).
- The wearing of masks is mandatory by both our tour leaders and guests.
- We encourage everyone to wash hands at every opportunity in public situations and use the provided sanitizer regularly – guides will carry hand sanitizer with them throughout the tour.
- please adhere to social distancing as best as possible. A minimum distance of 2 meters (6.5 feet) is generally required, however we realize this will be situationally dependent.
- Please keep all personal belongings in the vehicle in protective covering or on your person.
- The Rockjumper team will spray or wipe down all equipment with disinfectant after every use and/or trip.

Staff are instructed to maintain social distancing at all times. We at Rockjumper Birding take pride in our work and in our ability to keep our staff and guests happy, safe and healthy at all times.
